Any horse withdrawn from the sale or "No Show" except for serious injury or sickness (must furnish vet letter) will be assessed the consignment fee plus an additional \$250 withdrawal fee. Remember this is a contract.
- 3. Original current Coggins dated within 1 year of sale date MUST accompany horses to sale. Horses coming in from outside of Texas must have original current health certificate dated within 30 days of sale date. Horses will not be allowed to unload without these items.
